20.1 The Chair noted the purpose of this second session of the Board meeting was to consider the proposals for the development of the Severn Campus and the Board Effectiveness Review.

#### 20/21 Proposals for the Severn Campus

- 21.1 Proposals for the development of the Severn Campus [BG20/16]
- 21.1.1 The Vice Chancellor presented the paper on the overall vision for the Severn Campus and recommendations on each of the components. He noted that the development of the Severn Campus had been a long-held ambition of the University and the Board since the early 2000s.

- 21.1.7 It was noted the Finance & Development Committee had considered the plans and supported the proposals as part of the University's core strategies. The Students' Union President added students were very supportive of the plans.
- 21.1.8 The Board approved the following recommendations:
  - i) Three Counties Centre for Health and Medicine that the University submit a planning application for the refurbishment of the former Worcester News building and proceed with the appointment of a contractor to deliver the project. (Section 2 of BG20/16)
  - ii) IICEC that the project proceed to planning but that the appointment of contactors is subject to sufficient funding (University and third party) being available. (Section 3 of BG20/16))
  - iii) Severn Campus Infrastructure that the infrastructure project proceed to planning and that contractors are appointed as appropriate to achieve the requirements of the Rebuilding Britain funding. (Section 4 of BG20/16))
  - iv) That a Severn Campus Project Board is established (Section 5 of BG20/16)).
