Sarah Waller is an Associate Specialist at the Association for Dementia Studies with a particular interest in [developing enabling environments](#) for people living with dementia.

She developed and directed The King's Fund's award winning, internationally recognised Enhancing the Healing Environment (EHE) programme from its inception in 2000 to its transfer to the University of Worcester in 2015. From 2009 the EHE programme focused on developing more supportive design for people with dementia. Sarah led the development of the dementia friendly environmental assessment tools which are now in use nationally and internationally.

Sarah has had a long and distinguished career in the NHS and Department of Health both in nursing and human resource management. She is a Trustee of Chelsea and Westminster Health Charity and chairs their Arts Advisory Board. A former NHS Trust vice chair and member of the independent Liverpool Care Pathway Review Panel she was appointed CBE in 2008 for services to Nursing and the NHS.
